A BILL FOR AN ACT

To appropriate the sum of \$4,746.25 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the Division of Public Safety's security support during the recent APIL Board of Directors Meeting held in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$4,746.25 is hereby appropriated from the
2 Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the Division
3 of Public Safety's security support during the recent APIL Board of Directors Meeting
4 held in the State of Kosrae; and for other purposes.

5 Section 2. Apportionment. The amount shall be apportioned as follows:

6 1. Compensation	\$4,400.00
7 2. Fuel	\$346.25

8 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be
9 allotted, managed, administered and accounted for in accordance with applicable law. The
10 allottee of the fund appropriated shall be the Governor of the State of Kosrae, who shall be
11 responsible for ensuring that these funds, or so much thereof as may be necessary, are
12 used for the purpose of which are appropriated and that no obligations are incurred in
13 excess of the sum appropriated.
