### A BILL FOR AN ACT

To appropriate the sum of \$5,000.00 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the College of Micronesia Kosrae Campus Security Office Renovation and Student Activities; and for other purposes.

#### BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. Appropriation. The sum of \$5,000.00 is hereby appropriated from the Local
- 2 Revenue Fund of the Kosrae State Treasury for the purpose of funding the funding the activities for the
- 3 College of Micronesia, Kosrae Campus.
- Section 2. Apportionment. The amount shall be apportioned as follows:
- A. Campus Security Office Renovation

\$3,000

6 B. Student Activities

\$2,000

- 7 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
- 8 managed, administered and accounted for in accordance with applicable laws. The allottee of the fund
- 9 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that
- these funds, or so much thereof as may be necessary, are used for the purpose for which are appropriated
- and that no obligations are incurred in excess of the sum appropriated. The authority of the allottee to
- obligate the fund appropriated by this act shall be until expended.
- Section 4. <u>Effective Date</u>. This act shall become law upon approval by the Governor or upon its
- becoming law without such approval.
