A BILL FOR AN ACT

To appropriate the sum of \$5,000.00 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the College of Micronesia Kosrae Campus Security Office Renovation and Student Activities; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$5,000.00 is hereby appropriated from the Local
2 Revenue Fund of the Kosrae State Treasury for the purpose of funding the funding the activities for the
3 College of Micronesia, Kosrae Campus.

4 Section 2. Apportionment. The amount shall be apportioned as follows:

5 A. Campus Security Office Renovation	\$3,000
6 B. Student Activities	\$2,000

7 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
8 managed, administered and accounted for in accordance with applicable laws. The allottee of the fund
9 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that
10 these funds, or so much thereof as may be necessary, are used for the purpose for which are appropriated
11 and that no obligations are incurred in excess of the sum appropriated. The authority of the allottee to
12 obligate the fund appropriated by this act shall be until expended.

13 Section 4. Effective Date. This act shall become law upon approval by the Governor or upon its
14 becoming law without such approval.


