A BILL FOR AN ACT

To appropriate the sum of \$8,000.00 from the Revenue Fund of the Kosrae State Treasury to fund the 2023 International Women's Day celebration by each community women association; and for other purposes.

	BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE
1	Section 1. Appropriation. The sum of \$8,000.00 is hereby appropriated from the
2	Revenue Fund of the Kosrae State Treasury to fund the 2023 International Women's Day
3	celebration by each community women association; and for other purposes.
4	Section 2. Apportionment. The sum appropriated shall be apportioned as follows:
5	1. Tafunsak Women Association \$2,000.00
6	2. Lelu Women Association \$2,000.00
7	3. Malem Women Association \$2,000.00
8	4. Utwe Women Association \$2,000.00
9	Section 3. Reporting Requirement. After such fund is released from the State
10	Treasury, each community women association is required to submit an expense report of
11	all spending relative to the fund usage, two months after completion of activities. The
12	report shall be submitted to the Office of the Governor and the Kosrae State Legislature.
13	Section 4. Allottee. All funds appropriated by this act shall be allotted, managed,
14	and accounted for in accordance with applicable laws. The allottee of the funds
15	appropriated by this act shall be the Governor of the State of Kosrae, who shall be
16	responsible for ensuring that these funds, or so much thereof as may be necessary are

responsible for ensuring that these funds, or so much thereof as may be necessary, are used as for the purpose of funding the International Women's Day and that no obligations are incurred in excess of the sum appropriated.
