A BILL FOR AN ACT

To appropriate the sum of \$12,000 from the Local Revenue Fund of the Kosrae State Treasury to subsidize the operation of the Utwe Water System; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum \$12,000.00 from the Local Revenue Fund of the Kosrae
2 State Treasury to subsidize the operation of the Utwe Water System.


3 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
4 managed, administered and accounted for in accordance with applicable laws. The allottee of the fund
5 appropriated shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that
6 these funds, or so much thereof as may be necessary, are used for the purpose for which are appropriated
7 and that no obligations are incurred in excess of the sum appropriated.

8 Section 3. Effective Date. This act shall become law upon approval by the Governor or upon its
9 becoming law without such approval.




