A RESOLUTION

To amend the Governor's Declaration of a State of Emergency made on March 17<sup>th</sup>, 2020 in the following respect: Section 2) of the order made by the Governor under the Declaration be amended to read "2) The Department of Finance and Administration shall identify sources of funding that are available to carry out this order and recommend to the Governor soon as practicable additional supplemental budget request to the Legislature".

1           **WHEREAS**, the Governor made a Declaration of a State of Emergency on March 17<sup>th</sup>,  
2 2020 ;and

3           **WHEREAS**, members of the Twelfth Kosrae State Legislature pursuant to Section 13  
4 of Article V of the Constitution of the State of Kosrae considered the Declaration of State of  
5 Emergency ;; and

6           **WHEREAS**, members of the Twelfth Kosrae State Legislature after considering section  
7 2) of the order made by the Governor under the Declaration of State of Emergency which  
8 reads: " 2) The Department of Finance and Administration shall identify sources of funds  
9 necessary to carry out this order and shall ensure that any unessential/non-urgent spending is  
10 suspended until further notice" perceived that section 2) of the order made under the  
11 Declaration of State of Emergency to be inappropriate as to certain parts thereof and  
12 consequently further perceived that section 2) of the order made under the Declaration of State  
13 of Emergency should be amended ; NOW AND THEREFORE

14           **BE IT RESOLVED**, by members of the Twelfth Kosrae State Legislature that pursuant  
15 to Article V, Section 13 of the Kosrae State Constitution that section 2) of the order made under  
16 the Declaration of State of Emergency made by the Governor on March, 17, 2020 which reads:
