4 daughter, Tulpe Mike; and

5 **WHEREAS**, the late Bernis B. Nena was a native of Utwe who had sacrificed most of
6 his life in making the village of Utwe and its people, a better community; and

7 **WHEREAS**, the late Bernis B. Nena had diligently served the people and the
8 government of Kosrae State; He began serving the Kosrae State Government as an Educator for
9 the Department of Education in January of 1987, where he continued to serve as a Classroom
10 Teacher for the Utwe Elementary School (UES) until his untimely passing at the age of fifty-nine
11 (59) years old, having served a total of thirty-five (35) years for the state government; and

12 **WHEREAS**, the late Bernis B. Nena was considered by his friends, colleagues, and
13 families as a passionate, hardworking individual who has contributed greatly in unifying the
14 minds and futures of the sons and daughters of Utwe; and

15 **WHEREAS**, the late Bernis B. Nena also served as a Councilman for the 16th Utwe
16 Municipal Council from 2018 to 2020, where he contributed so much as the Vice Chairman of
17 the 16th UMC and also as a Chairman of the municipal task force; **NOW & THEREFORE**




