To further amend State Law No. 11-171, as amended by S.L. Nos. 12-04 and 12-22, to amend the lapse date on certain Amended Compact Funded program/project, namely the Department of Health Services, and the Kosrae Island Resource Management Authority in the State of Kosrae; and for other purposes.
BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE
Section 1. <u>Purpose</u> . The purpose of this proposal is to extend the lapse date on certain Amended
Compact Funding program/project in the State of Kosrae.
Section 2. <u>Amendment</u> . State Law No. 11-171, is further amended as follows:
"Section 1. Appropriations. Operation of the Executive. The sum of \$6,718,289 or so
much thereof as may be necessary, is appropriated from the Amended Compact Fund; the sum of
\$870,731, or so much thereof as may be necessary, is appropriated from the State Revenue Fund
the sum of \$960374, or so much thereof as may be necessary, is appropriated from the United
States Grant Fund; and the sum of \$382,246 or so much thereof as may be necessary, is
appropriated from the Foreign Assistance Fund for the operation of the Executive Branch for the
fiscal year ending September 30, 2019, with Section 2 at subsection 16, Amended Compact Fun
being extended to September 30, 2020.
Section 2. Apportionment. Operation of the Executive. The sums appropriated by Section
1 of this act are apportioned as follows:
