A BILL FOR AN ACT

To further amend State Law No. 11-171, as amended by S.L. Nos. 12-04 and 12-22, to amend the lapse date on certain Amended Compact Funded program/project, namely the Department of Health Services, and the Kosrae Island Resource Management Authority in the State of Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this proposal is to extend the lapse date on certain Amended
2 Compact Funding program/project in the State of Kosrae.

3 Section 2. Amendment. State Law No. 11-171, is further amended as follows:

4 "Section 1. Appropriations. Operation of the Executive. The sum of \$6,718,289 or so
5 much thereof as may be necessary, is appropriated from the Amended Compact Fund; the sum of
6 \$870,731, or so much thereof as may be necessary, is appropriated from the State Revenue Fund;
7 the sum of \$960374, or so much thereof as may be necessary, is appropriated from the United
8 States Grant Fund; and the sum of \$382,246 or so much thereof as may be necessary, is
9 appropriated from the Foreign Assistance Fund for the operation of the Executive Branch for the
10 fiscal year ending September 30, 2019, with Section 2 at subsection 16, Amended Compact Fund
11 being extended to September 30, 2020.

12 Section 2. Apportionment. Operation of the Executive. The sums appropriated by Section
13 1 of this act are apportioned as follows:

9 Section 11. Appropriation. The sum of \$4,582,910, or so much thereof as may be
10 necessary, is appropriated from the Amended Compact Fund; the sum of \$31,232, or so much
11 thereof as may be necessary, is appropriated from the Revenue Fund; and the sum of \$45,249, or
12 so much thereof as may be necessary, is appropriated from the Foreign Assistance Fund for the
13 purpose of funding certain Governmental programs, grants, and contributions for the fiscal year
14 ending September 30, 2019, by which Section 12, at subsection 12, Amended Compact Fund
15 being extended to September 30, 2020.

16 Section 12. Apportionment. The sums appropriated by Section 11 of this act are
17 apportioned as follows:
