A RESOLUTION

To further extend the Governor's Declaration of a State of Emergency made on March 17th, 2020 as amended and extended.

1 **WHEREAS**, the Governor made a Declaration of a State of Emergency on March 17th,
2 2020 (the Declaration of a State of Emergency) ;and

3 **WHEREAS**, members of the Twelfth Kosrae State Legislature on April 13, 2020
4 considered whether to extend the Declaration of a State of Emergency which had by then been
5 amended, pursuant to Section 13 of Article V of the Constitution of the State of Kosrae and then
6 resolved to extend the Declaration of a State of Emergency as amended for a period of another
7 thirty (30) days from April 17, 2020.

8 **WHEREAS**, members of the Twelfth Kosrae State Legislature on May 13, 2020
9 considered whether to extend the Declaration of a State of Emergency as amended, pursuant to
10 Section 13 of Article V of the Constitution of the State of Kosrae and then resolved to extend the
11 Declaration of a State of Emergency as amended for a period of another thirty (30) days from
12 May 17, 2020

13 **WHEREAS**, members of the Twelfth Kosrae State Legislature on June 15, 2020 considered
14 whether to extend the Declaration of a State of Emergency as amended, pursuant to Section 13
15 of Article V of the Constitution of the State of Kosrae and then resolved to extend the
16 Declaration of a State of Emergency as amended for a period of another thirty (30) days from
17 June 17, 2020

1 **WHEREAS**, members of the Twelfth Kosrae State Legislature on July 10, 2020 considered
2 whether to extend the Declaration of a State of Emergency as amended, pursuant to Section 13 of
3 Article V of the Constitution of the State of Kosrae and then resolved to extend the Declaration
4 of a State of Emergency as amended for a period of ninety (90) days from 18 July, 2020 and
5 expires on October 15, 2020.

6 **WHEREAS**, members of the Twelfth Kosrae State Legislature on September 29, 2020
7 considered whether to extend the Declaration of the State of Emergency as amended, pursuant to
8 Section 13 of Article V of the Constitution of the State of Kosrae and the resolved to extend the
9 Declaration of a State of Emergency as amended for a period of ninety (90) days from October
10 16, 2020 and expires on January 13, 2021.

11 **WHEREAS**, members of the Twelfth Kosrae State Legislature pursuant to Section 13
12 of Article V of the Constitution of the State of Kosrae considered the Declaration of State of
13 Emergency as amended and extended ; and

14 **WHEREAS**, members of the Twelfth Kosrae State Legislature after noticing that the
15 Declaration of State of Emergency as amended and extended is due to expire on 13 January,
16 2021 and perceiving that COVID-19 still remains a threat in regards to which precautionary
17 measures need to be further established, maintained and supplemented and thereby perceiving
18 that it is essential that the Declaration of State of Emergency as amended and extended which
19 will expire on 13 January, 2021 thereafter be extended by 90 days to enable the Kosrae State to

1 continue to be in a state of preparedness to adequately respond to the threat posed by COVID-19

2 ; NOW AND THEREFORE

3 **BE IT RESOLVED**, by members of the Twelfth Kosrae State Legislature that pursuant

4 to Article V, Section 13 of the Kosrae State Constitution that the Declaration of State of

5 Emergency as amended and extended be further extended for a period of ninety (90) days from

6 14 January, 2021 and expires on April 14, 2021.”


