A RESOLUTION

Urging the Governor to forthwith issue a declaration of emergency pursuant to Section 13 of Article V of the Constitution of the State of Kosrae and make the following appropriate decrees to cancel or postpone until further notice all upcoming conferences and workshops scheduled to be held in the State of Kosrae and any other decrees the Governor sees fit.

1 **WHEREAS**, the Corona Virus (COVID-19) continues to be fatal and life-threatening to
2 humanity; and

3 **WHEREAS**, the Corona Virus (COVID-19) has taken a devastating toll on the number of
4 cases identified and there is a worldwide escalating fatality rate; and

5 **WHEREAS**, the people of Kosrae have expressed growing concerns and harbor
6 constant fear of the uncertainties and serious risks presented by the Corona Virus outbreak; and

7 **WHEREAS**, the leadership of the State of Kosrae has taken pre-emptive health and port
8 entry measures, to endeavor to shield the COVID-19 from spreading into the State of Kosrae;
9 and

10 **WHEREAS**, it has come to the attention of the 12th Kosrae State Legislature that
11 conferences and workshops have already been arranged to be held in the State of Kosrae, and
12 that allowing these events to take place will further place the of people in the State of Kosrae
13 at risk of being susceptible to the Corona Virus (COVID-19); **NOW AND THEREFORE**

14 **BE IT RESOLVED**, that the Twelfth Kosrae State Legislature, during their Third
15 Regular Session, hereby urges the Governor to forthwith issue a declaration of emergency
