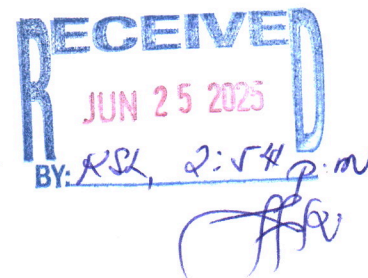





**A BILL FOR AN ACT**

To appropriate the sum of \$125,000.00 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of subsidizing the KUA household power program funded through a CFSM subsidy; and for other purposes

**BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE**

1           Section 1. Appropriation. The sum of \$125,000.00 is hereby appropriated from the Local  
2 Revenue Fund of the Kosrae State Treasury for the purpose of subsidizing the KUA household  
3 power program funded through a CFSM subsidy.

4           Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,  
5 managed, administered and accounted for in accordance with applicable laws. The allottee of the  
6 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible for  
7 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for  
8 which are appropriated and that no obligations are incurred in excess of the sum appropriated.  
9 The authority of the allottee to obligate funds appropriated by this act shall until expended.

10           Section 4. Effective Date. This act shall become law upon approval by the Governor or  
11 upon its becoming law without such approval.

ARTICLE 1

To appropriate the sum of \$12,000,000 from the Local Revenue Fund of the Kansas State Treasury for the purpose of subsidizing the KTA household power program funded through a CPM subsidy and for other purposes.

SECTION 1. SHORT TITLE

Section 1. Appropriation. The sum of \$12,000,000 is hereby appropriated from the Local Revenue Fund of the Kansas State Treasury for the purpose of subsidizing the KTA household power program funded through a CPM subsidy.

Section 2. Allocation and Disbursement. All funds appropriated by this act shall be allocated, managed, administered and accounted for in accordance with applicable laws. The allocation of the funds appropriated shall be the responsibility of the Governor of the State of Kansas, who shall be responsible for ensuring that these funds are used for the purposes for which are appropriated and that no expenses are incurred in excess of the sum appropriated. The authority of the director to obligate funds appropriated by this act shall expire on

Section 3. Effective Date. This act shall become law upon approval by the Governor or upon becoming law without such approval.


