A RESOLUTION

Consenting to the nomination of Mr. Jacob C. Ned to serve as a member of the Kosrae Sports Council.

1 **WHEREAS**, pursuant to Section 12 of Article V of the Kosrae State Constitution,
2 the Governor has the constitutional authority to appoint members comprising State
3 Boards, Authority, Commissions or Agencies with the advice and consent of the
4 Legislature; and

5 **WHEREAS**, Section 7.1001 of Title 7 of the Kosrae State Code established the
6 Sports Council as one of the government-financed agencies of the State and by Section
7 7.1002 is given the authority to (1) formulate government policy regarding, and
8 supervise, sports, leagues and games, and the State's participation in extra-State
9 tournaments; (2) recommend to the Legislature and Executive the purchase of equipment,
10 improvement and use of public land for recreational facilities, and the hiring of recreation
11 staff; and (3) collect entrance fees from participants in games and tournaments and
12 admission fees from persons attending events at the gymnasium and other recreational
13 facilities; and

14 **WHEREAS**, each board member serves for a period of 2 years, pursuant to
15 Section 7.1001 of Title 7 of the Kosrae State Code; and

16 **WHEREAS**, by Governor's Message No. 12-306, The Honorable Carson K.
17 Sigrah has nominated Mr. Jacob C. Ned to serve as a member of the Kosrae Sports
