A RESOLUTION

Requesting the Office of the State Public Auditor to conduct a special audit on the expenditures of public funds, namely the FY2020 FSM Health Sector Grant COVID-19 Supplemental (which includes the State Quarantine Facility construction project) and the CARES ACT funding in the State of Kosrae administered by the State Department of Finance & Administration and report to the Kosrae State Legislature.

1	WHEREAS, pursuant to Article IV, Section 12, of the Kosrae State Constitution
2	the Legislature has and may exercise all the authority and attributes inherent in legislative
3	bodies, including the power to institute and conduct investigations, issue subpoenas to
4	witnesses and other concerned parties, and administer oaths; and
5	WHEREAS, further pursuant to Section 10.407 of Title 10 of the Kosrae State
6	Code, the Kosrae State Legislature has the authority to require a special audit of a
7	particular agency or entity, or may require the audit of the expenditure of public funds, or
8	a portion thereof, at any other time than normal annual or biennial audits; and
9	WHEREAS, it is the aspiration of the 12 th Kosrae State Legislature to be fully
10	informed of the performance and expenditure of public funds, namely the FY2020 FSM
11	Health Sector Grant COVID-19 Supplemental (which includes the State Quarantine
12	Facility construction project) and CARES ACT fundings in the State of Kosrae,
13	administered by the State Department of Finance & Administration; and
14	WHEREAS, further pursuant to Section 10.407 of Title 10 of the Kosrae State
15	Code, a special audit request may establish reasonable requirements for the timing of the
16	special audit and special audit reports, or leave the discretion to the State Public Auditor
17	to determine the most feasible and reasonable time to initiate the special audit; NOW &
