A RESOLUTION

To further extend the Governor's Declaration of a State of Emergency made on March 17<sup>th</sup>, 2020 as amended and extended on April 15, 2020, May 14, 2020, June 16, 2020, July 16, 2020, October 9, 2020, December 23, 2020, June 4, 2021, October 6, 2021, February 1, 2022, February 25, 2022, and May 30, 2022.

1           **WHEREAS**, the Governor made a Declaration of a State of Emergency on March 17<sup>th</sup>,  
2           2020, which was amended and extended on April 15, 2020, May 14, 2020, June 16, 2020, July  
3           16, 2020, October 9, 2020, December 23, 2020, June 4, 2021, October 6, 2021, February 1, 2022,  
4           February 25, 2022, and May 30, 2022; and

5           **WHEREAS**, members of the Twelfth Kosrae State Legislature pursuant to Section 13 of  
6           Article V of the Constitution of the State of Kosrae considered the Declaration of State of  
7           Emergency as amended and extended; and

8           **WHEREAS**, members of the Twelfth Kosrae State Legislature after noticing that the  
9           Declaration of State of Emergency as amended and extended is due to expire on 31<sup>st</sup> July, 2022  
10          and perceiving that COVID-19 still remains a threat in regards to which precautionary measures  
11          need to be further established, maintained and supplemented and thereby perceiving that it is  
12          essential that the Declaration of State of Emergency as amended and extended thereafter be  
13          further extended by another 31 days to enable the Kosrae State to continue to be in a state of  
14          preparedness to adequately respond to the threat posed by COVID-19; **NOW AND**



4 2020, June 16, 2020, July 16, 2020, October 9, 2020, December 23, 2020, June 4, 2021, October  
5 6, 2021, February 1, 2022, and February 25, 2022, be further extended for a period of thirty-one  
6 (31) days from August 1<sup>st</sup> 2022 and expires on August 31<sup>st</sup>, 2022; and
