A BILL FOR AN ACT

To amend State Law No. 12-02 as further amended by State Law No. 12-187, extending the lapse date for Section 2(2) Kosrae Hospital Design project; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to extend the lapse date for the Kosrae
2 Hospital Design project.

3 Section 2. Amendment. State Law No. 12-02 is hereby amended to read as follows:

4 "...Section 2. Apportionment. The sum appropriated herein above shall be apportioned
5 as follows:


8 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
9 managed, administered and accounted for in accordance with applicable laws. The allottee of
10 the funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
11 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
12 which are appropriated and that no obligations are incurred in excess of the sum appropriated.
13 The authority of the allottee to obligate funds appropriated by this act on Section 2(1) shall lapse
14 on March 31, 2023 and Section 2(2) shall lapse on March 31, 2027."

15 Section 4. Effective Date. This act shall become law upon approval by the Governor or
16 upon its becoming law without such approval.
