A BILL FOR AN ACT

To further amend State Law No. 12-92, as amended by State Law Nos. 12-100, 12-129 and 12-130 at Sections 2(2)(e), 14(e), 11, and 12 (8) to extend lapse date from September 30, 2021 to later specified date for each programs/projects; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this act is to extend the lapsed date for Section 2,  
2 subsection 2(e), Section 14(e), Section 11, and 12 (8) extending the lapse date to a later date as  
3 specified for each . The intend of the extensions are for the Department of Education to allow  
4 applicable time for procurement of School bus for the Department of Education from September  
5 30, 2021 until September 30, 2022; and for procurement of .

6           Section 2. Amendment. State Law No. 12-92 as amended by State Law Nos. 12-100, 12-  
7 129 and 12-130, is further amended at Section 2, subsections 2(e), to read as follows:

8           “...Section 1. Appropriations. Operation of the Executive. The sum of \$6,904,866, or so  
9 much thereof as may be necessary, is appropriated from the Amended Compact Fund; the sum  
10 of \$1,062,205 or so much thereof as may be necessary, is appropriated from the State Revenue  
11 Fund; the sum of \$971,401 ,or so much thereof as may be necessary, is appropriated from the  
12 United States Grant Fund; and the sum of \$455,113 or so much thereof as may be necessary, is  
13 appropriated from the Foreign Assistance Fund for the operation of the Executive Branch for the  
14 fiscal year ending September 30, 2021. Provided that the lapse date for subsection 2(e) ending on  
15 September 30, 2022 and subsection 14(e) ending on March 31, 2022 .
