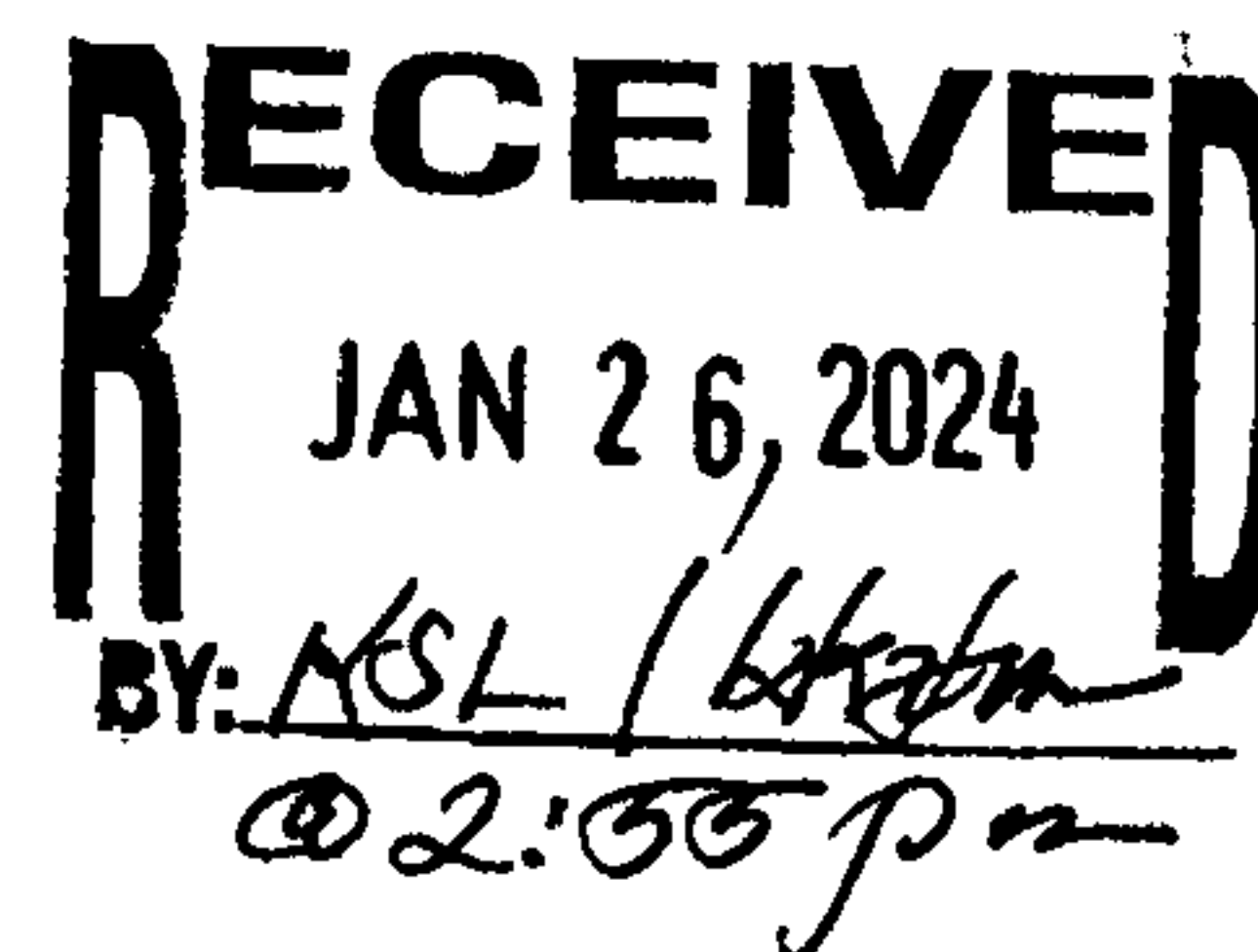



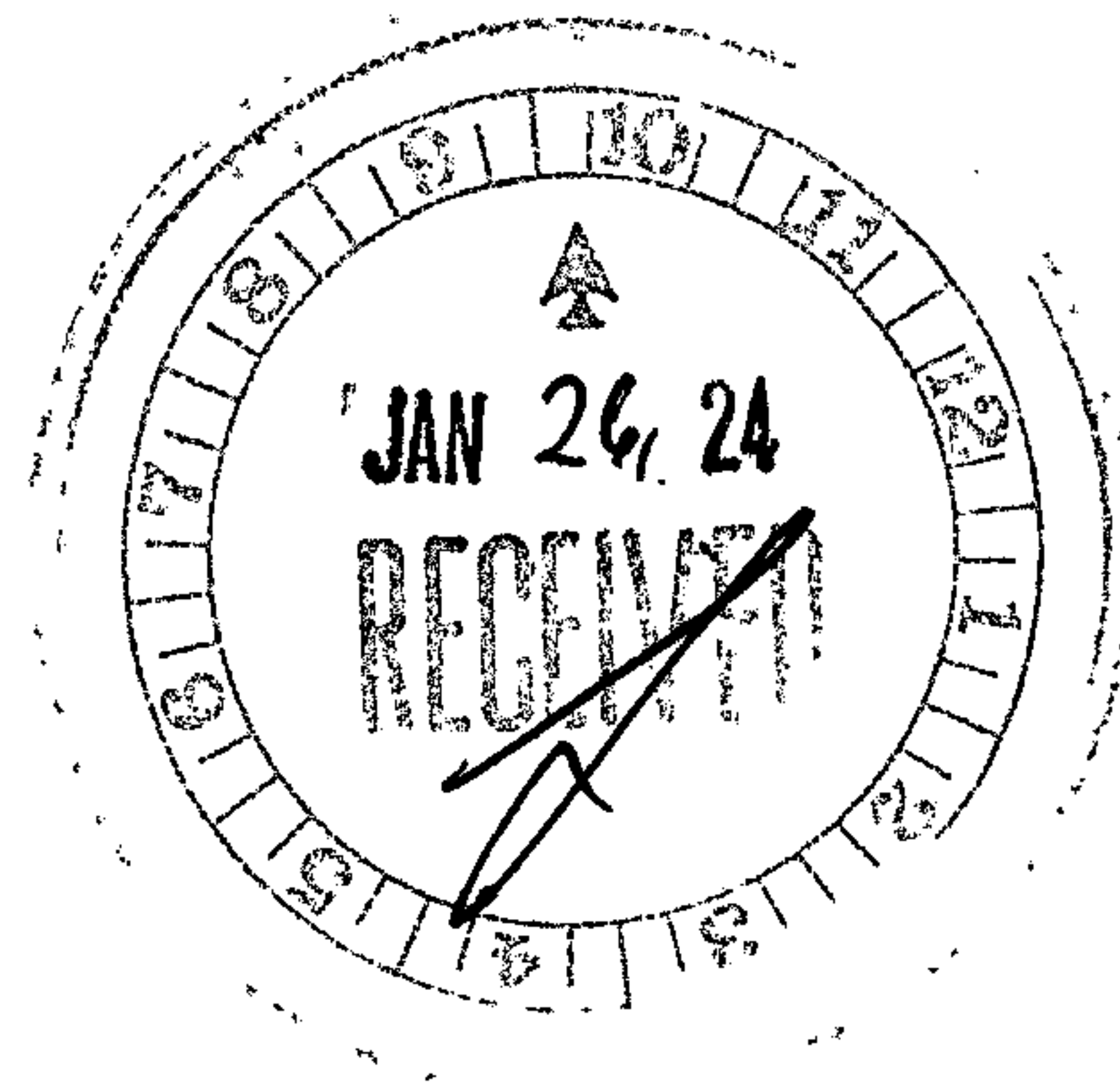
Dear Governor Palik,

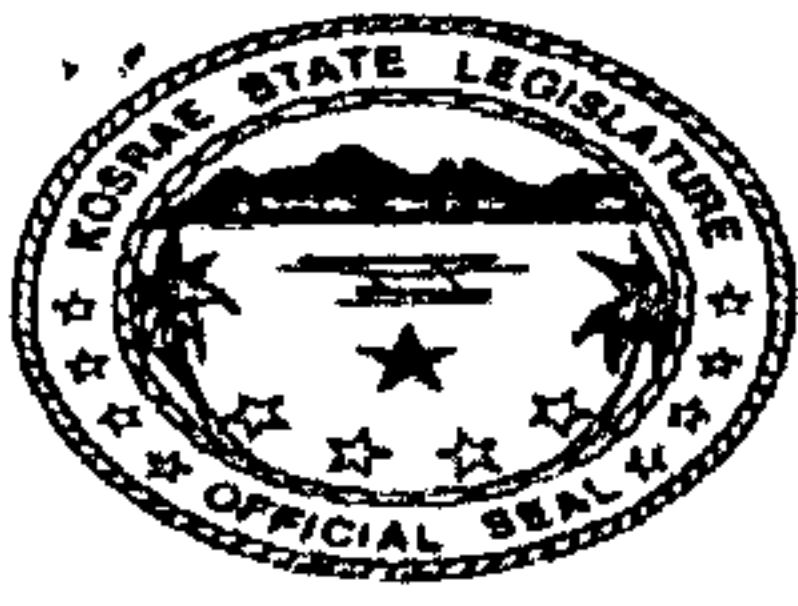





A BILL FOR AN ACT

To amend Title 7 of the Kosrae State Code by amending Section 7.402, to alter the title of KIRMA authority staff from “Program Administrator” to “Executive Director”, to be applied elsewhere applicable in the Code; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to amend the Kosrae State Code by
2 amending Section 7.402, to alter the title of KIRMA authority staff from “Program
3 Administrator” to “Executive Director”, to be applied elsewhere applicable in the Code; and for
4 other purposes.

5 Section 2. Amendment. Title 7, Chapter 4, Section 7.402 of the Kosrae State Code is
6 hereby amended to read as follows:

7 “Section 7.402. Authority staff.

8 The Authority selects a full-time Executive Director who administers the functions of the
9 Authority and has such duties and responsibilities as may be delegated to him by the Authority.
10 The Executive Director may be assisted in his duties by supporting staff as the Authority may
11 deems necessary.”

12 Section 3. Effective Date. This act shall become law upon approval by the Governor or
13 upon its becoming law without such approval.


