



A BILL FOR AN ACT

To amend Title 7 of the Kosrae State Code by amending Section 7.402, to alter the title of KIRMA authority staff from "Program Administrator" to "Executive Director", to be applied elsewhere applicable in the Code; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. <u>Purpose</u>. The purpose of this Act is to amend the Kosrae State Code by
- amending Section 7.402, to alter the title of KIRMA authority staff from "Program
- Administrator" to "Executive Director", to be applied elsewhere applicable in the Code; and for
- 4 other purposes.
- Section 2. <u>Amendment.</u> Title 7, Chapter 4, Section 7.402 of the Kosrae State Code is
- 6 hereby amended to read as follows:
- "Section 7.402. Authority staff.
- 8 The Authority selects a full-time Executive Director who administers the functions of the
- 9 Authority and has such duties and responsibilities as may be delegated to him by the Authority.
- The Executive Director may be assisted in his duties by supporting staff as the Authority may
- 11 deems necessary."
- Section 3. Effective Date. This act shall become law upon approval by the Governor or
- upon its becoming law without such approval.
- PASSED BY THE 13TH KOSRAE STATE LEGISLATURE ON THE 25th DAY OF
- 15 JANUARY, 2024.
