### A BILL FOR AN ACT

861

To further amend Title 14 of the Kosrae State Code at, Chapter 1, by inserting a new Section 14.109 to establish an exclusive industrial zone; to further amend subsection 1 (iii) to clarify its meaning; and to further amend subsection 1 to include a subsection 1 (iv); and for other purposes.

#### BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1	Section 1. <u>Purpose</u> . The purpose of this act is to amend Title 14 of the
2	Kosrae State Code at Chapter 1, by inserting a new Section 14.109, to establish an
3	exclusive economic and industrial zone. The areas to be included in said zone will
4	be the Kosrae International Airport with the adjacent port and dock; a total land
5	area of 109.26 acres, which is equivalent to 442,162.40 Square meters; to further
6	amend Title 14, of the Kosrae State Code by inserting a new subsection 1 (iv) to
7	give meaning to"Activities" and operations", and to further amend 14.109 to
8	clarify "respective management and administration", and for other purposes.
9	Section 2. <u>Amendment</u> . Section 14.109 of Title 14 of the Kosrae State
10	Code is hereby amended to read as follows:
11	Section 14.109. Exclusive Economic and Industrial Zone.
12	(1) Kosrae International Airport and the port and dock adjacent to it
13	shall an exclusive and economic and industrial zone.
13	(i) The established zone is a total land area of 109.26 acres;
14	an equivalent of 442.16240 square meters.

15	(ii) Activities and operations on, within, and relate to
16	established zone shall be legal and authorized by law;
17	except where provided otherwise in this section.
18	(iii) Activities and operations on, within, and related to
19	established zone shall be based on set and established
20	schedule, including Sundays, by the respective management
21	and administration.
22	(iv) Activities and operations shall be confined to arrival and
23	departure of aircrafts and its regular operations, to include off-
24	loading and on-loading of cargo and passenger, and arrival
25	and departure of any maritime vessel, except that there shall be
26	no operation related activities of any kind on Sunday.
27	Respective management shall be the activity and operation
28	entity, agent, partner or owner. Administration shall be the
29	Kosrae State Government and Kosrae Port Authority.
30	Section 4. Effective Date. This act takes effect upon the approval of the
30	Governor or upon becoming law without such approval.
