

A BILL FOR AN ACT

To appropriate the sum of \$25,000 from the Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2025 for the purpose of providing funding assistance for the Kosrae women delegation participating in the 2025 Women’s Conference scheduled to be held in the State of Chuuk; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Appropriation. The sum of \$25,000 is hereby appropriated from the Revenue Fund of  
2           the Kosrae State Treasury for the fiscal year ending September 30, 2025 for the purpose of providing  
3           funding assistance for the Kosrae women delegation participating in the 2025 Women’s Conference  
4           to be held in the State of Chuuk.

5           Section 2. Apportionment. The amount appropriated in Section 1 of this act is apportioned as  
6           follows:

- 7           1. Kosrae Women’s Association ..... \$25,000

8           Section 3. Allottee. All funds appropriated by this act shall be allotted, managed, administered  
9           and accounted for in accordance with applicable laws. The allottee of the funds appropriated shall  
10          be the Governor of the State of Kosrae, who shall be responsible for ensuring that these funds, or so  
11          much thereof as may be necessary, are used for the purpose for which are appropriated and that no  
12          obligations are incurred in excess of the sum appropriated.

13          Section 4. Effective Date: This act takes effect upon the approval of the Governor or  
14          upon its becoming law without such approval.






