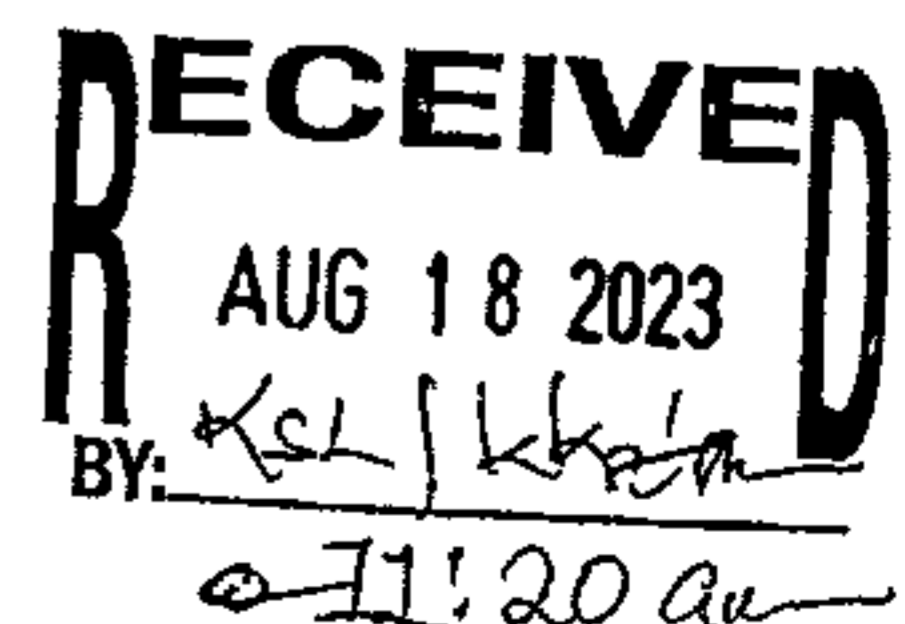

A BILL FOR AN ACT

To further amend State Law No. 12-190, as amended by State Law Nos. 13-04, 13-07, and 13-15, by amending Section 2 at subsection 1(c) to modify the Office of the Governor’s approved budget to include representation fund for the Governor under Contractual; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to amend State Law No. 12-190, as further
2 amended by State Law Nos. 13-04, 13-07, and 13-15 by amending Section 2 at Subsection 1(c) to
3 modify the Office of the Governor’s approved budget to include representation fund for the Governor
4 under Contractual under Local Revenue; and for other purposes.

5 Section 2. Amendment. State Law No. 12-190, Section 2 at subsection 1(c) is hereby
6 amended to read as follows:

7 “Section 2. Apportionment. Operation of the Executive. The sums appropriated by Section 1
8 of this act are apportioned as follows:


