Your Joint Committee on Ways & Means (W&M) & Judiciary & Governmental Operations (J&GO), to which was assigned L.B. No. 13-24 entitled, ***“To appropriate the sum of \$4,746.25 from the Local Revenue Fund of the Kosrae State Treasury for the purpose of funding the Division of Public Safety's security support during the recent APIL Board of Directors Meeting held in the State of Kosrae; and for other purposes,”*** begs leave to report as follows:

COMMITTEE ACTION:

Your joint committee met in an Executive Meeting on April 20th, 2023, following the Closing Day Session of the 1st Special Session and decided to dispose its action on L.B. No. 13-24.

COMMITTEE FINDINGS:

The intent of the subject bill is clearly stated in its title.

During the committee’s brief deliberations, the members were informed that this request was needed to supplement the Division of Public Safety for their security assistance, specifically for hours incurred after their normal working schedule, during the recent APIL Board of Directors Meeting here in Kosrae.

With minimal discussions, the committee agreed to move forward, in support of the bill.


COMMITTEE RECOMMENDATION:
