A RESOLUTION

Consenting and confirming the nomination of Dr. Tulensru E. Waguk (Ph.D), to continue to serve as the Director of the Department of Education.

1 **WHEREAS**, pursuant to Section 12 of Article V of the Kosrae State Constitution,
2 each Principal government department is under the supervision of the Governor and is
3 headed by a director; and

4 **WHEREAS**, pursuant to Section 12 of Article V of the Kosrae State Constitution,
5 directors are nominated and appointed by the Governor, with the advice and consent of
6 the Legislature, to serve at the pleasure of the Governor during his term of office and
7 until the appointment and qualification of their successors; and

8 **WHEREAS**, pursuant to Section 4.203(1) of Title 4 of the Kosrae State Code, the
9 Governor nominates a person to the directorship of a department within sixty days of
10 taking office following election; and

11 **WHEREAS**, through Governor's Message 12-02, transmitted and received on
12 January 24, 2109, The Honorable Carson K. Sigrah has nominated Dr. Tulensru Waguk
13 (Ph.D), to be the Director of the Kosrae State Department of Education; and

14 **WHEREAS**, pursuant to Section 4.203(2) of Title 4 of the Kosrae State Code,
15 within sixty days of the Legislature's receipt of a nomination the committee to which the
16 Speaker assigns the nomination calls and concludes hearings on the nomination, unless
17 the Legislature by resolution allows a further period; and
