A BILL FOR AN ACT

To appropriate the sum of \$25,000 from the Revenue Fund or any other appropriate fund of the Kosrae State Treasury to be managed by the Governor or his designee to be disbursed by the Governor or his designee to any applicant who is a franchisee of an international money transfer business who requires financial assistance by way of a short term secured loan to promptly meet any temporary shortfall of his or her franchise's working capital which is used to pay recipients residing in or visiting Kosrae State of any moneys that has been arranged to be transmitted their favor through the international money transfer business in which an applicant holds a franchise in; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$25,000 is hereby appropriated from the Revenue fund or any other appropriate fund of the Kosrae State Treasury which sum is to 2 be managed by the Governor or his designee to be disbursed by the Governor or his 3 designee to any applicant who is a franchisee of an international money transfer 4 businesses who requires financial assistance by way of a short term secured loan to 5 promptly meet any temporary shortfall of his or hers franchise's working capital which is 6 used to pay recipients residing in or visiting Kosrae State of any moneys that have been 7 arranged to be transmitted in their favor through the international money transfer 8 business in which the applicant holds a franchise in. 9 Section 2. The Governor or his designee before deciding whether to disburse any sum 10 from the sum of \$25,000 managed by him or his designee must by public notice invite 11 any franchisee of an international money transfer business who is residing in Kosrae 12 State and who promptly requires financial assistance by way of a short term secured loan 13

9	for ensuring that these funds, or such as may be necessary, are used for the purpose for		
0	which are appropiated and that no obligations are incurred in excess of the sum		
1	appropiated.		
2	Section 3. Effective Date. This Act takes effect upon the approval of the Governor		
3	or upon its becoming law without such approval.
