A BILL FOR AN ACT

To amend the Kosrae State Code by repealing Section 14.104 (5) and Section 14.107 to Chapter 1 of Part 1 of Title 14 and by inserting new Section 9.405 to Chapter 4 of Part 1 of Title 9; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

- Section 1. Purpose. The purpose of this Act is to amend the Kosrae State Code by 1 repealing sub-section Section 14.104 (5) and Section 14.107 to Chapter 1 of Part 1 of 2 Title 14 to terminate Kosrae Port Authority or its designee's duty to collect transshipment 3 fees and its accountability to pay such fees so collected to the Director of the Department 4 of Finance. 5 Section 2. Amendment. Section 14.104 (5) and Section 14.107 Chapter 1 of Part 6 1 of Title 14 are hereby repealed. 7 Section 3. Purpose. The purpose of this Act is to further amend the Kosrae State 8 Code by inserting new section 9.405 to Chapter 4 of Part 1 of Title 9 to enable the 9 Director of Administration and Finance in lieu of the Kosrae Port Authority or its designee
- 10 to collect transshipment fees from masters and agents of vessels using the ports and 11 docks in the State of Kosrae for transshipment or their vessels being involved with a 12
- transshipment within the the territorial waters of Kosrae State and to provide a definition 13 of transshipment fee. 14
- Section 4 Amendment: Title 9, Part 1, Chapter 4, Section 9.405 of the Kosrae State 15 Code is hereby amended to read as follows: 16

1	"Section 9. 405: Transshipment Fees collection: "The Director of Administration
2	and Finance or his or her designee shall collect a transshipment fee from masters and
3	agents of vessels, whose vessels have fish or other cargoes off-loaded from or
4	transfererred to using the ports or docks in the State of Kosrae or in the territorial waters
5	of Kosrae State
6	(1) Transshipment fee. A transshipment fee of \$1.25 per revenue ton of fish or
7	other cargoes off-loaded or transferred onto a carrier vessel at the port or dock
8	or in the territorial waters of Kosrae State
9	Section 5. Effective Date. This act takes effect upon the approval of the Governor
10	or upon its becoming law without such approval.
