A BILL FOR AN ACT

To appropriate the sum of \$39,920 from the General Fund of the Kosrae State Treasury to fund Kosrae State's participation in the Micronesian Exposition in Chuuk State as a supplemental budget; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$39,920 is from the General Fund of the Kosrae
2 State Treasury is hereby appropriated to fund Kosrae State's participation in the Micronesian
3 Expo in Chuuk.

4 Section 2. Apportionment. The amount shall be apportioned as follows:

5 1. Travel/ Related Expenses	\$34,920
6 2. Incidentals	\$5,000

7 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
8 managed, administered and accounted for in accordance with applicable laws. The allottee of
9 the fund appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
10 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
11 which are appropriated and that no obligations are incurred in excess of the sum appropriated.

12 Section 4. Effective Date. This act shall become law upon approval by the Governor or
13 upon its becoming law without such approval.
