**A RESOLUTION**

Expressing the Thirteenth Kosrae State Legislature's full support of the people's vote, that have elected Senator-Elect Yoslyn G. Sigrah as their representative to the 23<sup>rd</sup> FSM Congress and further requesting the FSM Congress to respect the votes of the people of the State of Kosrae, thus accepting Senator-Elect Yoslyn G Sigrah to be a member of the 23<sup>rd</sup> FSM Congress.

1           **WHEREAS**, Senator-Elect Yoslyn G. Sigrah was elected by "the people" of the  
2 State of Kosrae during the last National Election held during the month of July, 2023; and

3           **WHEREAS**, Since the election, the people of the State of Kosrae has been  
4 anxiously awaiting the seating of the remaining representative of the State of Kosrae and  
5 its people to the 23<sup>rd</sup> Congress of the FSM; and

6           **WHEREAS**, members of the Kosrae State Legislature as well as the people of the  
7 State of Kosrae has limited knowledge on the status of Senator-Elect Yoslyn Sigrah's  
8 standing; and

9           **WHEREAS**, it is the understanding of the people of the State of Kosrae that  
10 Senator-Elect Yoslyn Sigrah has met all the qualifications set forth under The FSM  
11 Constitution Article XI, Section 9 as well as under Section 201, Title 9 of the FSM Code,  
12 resulting in her inclusion on the ballots during the past FSM National elections; and

13           **WHEREAS**, the Kosrae State Legislature understands that the Congress of the  
14 FSM is the sole judge and qualifications of its members, but as leaders of the state we  
15 kindly request that the members of the 23<sup>rd</sup> FSM Congress favorably consider Senator-  
16 Elect Yoslyn Sigrah, be seated as a member of the 23<sup>rd</sup> FSM Congress; and
