A RESOLUTION

Supporting the recommendation made by Governor Sigrah for the nomination of Mr. Albert T. Welly to serve as the Kosrae State National Election Commissioner.

1 **WHEREAS**, The Honorable Carson K. Sigrah, Governor of the State of Kosrae, had
2 formally recommended Mr. Albert T. Welly to serve as the new Kosrae State National Election
3 Commissioner in an official letter dated November 10th, 2021, to His Excellency David W.
4 Panuelo, President of the Federated States of Micronesia; and

5 **WHEREAS**, the position had been left vacated since November of 2019, following the
6 passing of the late Henry E. Robert, the former Kosrae State National Election Commissioner;
7 and

8 **WHEREAS**, the people and leadership of Kosrae State are exceptionally familiar with
9 Mr. Welly's education background, qualifications, law-related work experiences, personality,
10 and interests; and

11 **WHEREAS**, Mr. Welly's vast work experiences in the field of law had been stoutly
12 rooted by his commitment and dedication serving the people for more than 20 years as a State
13 Senator of the 5th, 6th, 7th, 8th, 9th, and 10th Kosrae State Legislature; and

14 **WHEREAS**, Mr. Welly had also served as the Director for the FSM National Election
15 Commission from October, 2010 to November, 2015; and

16 **WHEREAS**, further due to the proximity of the next FSM National General Election in
17 March of 2023, the 12th Kosrae State Legislature considers it timely and proper, and wishes to
18 express its utmost support and confidence that Mr. Welly is highly capable, qualified, and has the

2 **THEREFORE**


3 **BE IT RESOLVED**, that this 12th Kosrae State Legislature, during its Twenty-Fourth

14 Welly.


