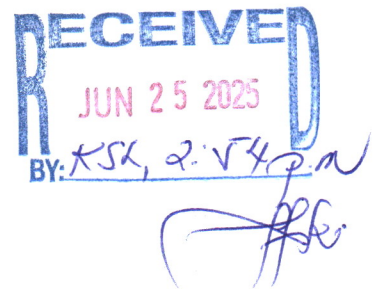

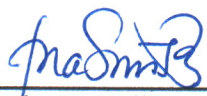

A BILL FOR AN ACT

To appropriate the sum of \$15,000.00 from the Local Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2025 for the purpose of providing operational subsidy for the Utwe Water System; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$15,000.00 is hereby appropriated from the
2 Local Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30,
3 2025 for the purpose of providing operational subsidy for the Utwe Water System.

4 Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be
5 allotted, managed, administered, and accounted for in accordance with applicable laws.
6 The allottee of the funds appropriated shall be the Governor of the State of Kosrae, who
7 shall be responsible for ensuring that these funds, or so much thereof as may be necessary,
8 are used for the purpose for which are appropriated and that no obligations are incurred in
9 excess of the sum appropriated and funds shall remain available until expended.

10 Section 3. Effective Date. This act takes effect upon the approval of the Governor
11 or upon its becoming law without such approval.

BE IT ENACTED BY THE KOSOVA STATE LEGISLATURE

1 Section 1. *(The portion)* The sum of 217,000.00 is hereby appropriated from the
2 Local Revenue Fund of the Kosovo State Treasury for the fiscal year ending September 30,
3 2022 for the purpose of providing operational subsidy for the Law M and for other
4 purposes. *Section 2. (Funds and)* *These* *Do not* All funds appropriated by this act shall be
5 allocated, managed, administered, and accounted for in accordance with applicable laws.
6 The allocation of the funds appropriated shall be the Governor of the State of Kosovo, who
7 shall be responsible for ensuring that these funds are used for the purposes as may be necessary,
8 and used for the purposes for which are appropriated and that no obligations are incurred in
9 excess of the sum appropriated and funds shall remain available until expended.
10 Section 3. *(Effective Date)* This act shall take effect upon the approval of the Governor
11 or upon its becoming law without such approval.

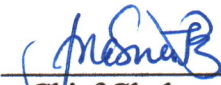
