12 graduated in 1986; After he graduated from high school, he went to Texas and attended the

14 **WHEREAS**, the late Senator Daniel B. Palik began his professional career in 1994,
15 where he dedicated most of his time working for the Continental Airlines, which currently called
16 United Airlines, until 2019, for a period over 25 years; A year later in July of 2020, the late
17 Senator Daniel B. Palik was duly elected by the people of Lelu where he became; and
