A BILL FOR AN ACT

To appropriate the sum of \$2,000.00 from the Local Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2025 for the purpose of providing funding assistance to the 2024 General Election for the Office of the Council of the Utwe Municipal Government; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$2,000 is hereby appropriated from the Local
2 Revenue Fund of the Kosrae State Treasury for the fiscal year ending September 30, 2025 for the
3 purpose of providing funding assistance to the 2024 General Election for the Office of the
4 Council of the Utwe Municipal Government.

5 Section 2. Apportionment. The amount shall be apportioned as follows:

6 (1) 2024 General Election/Office of the Council (UMG)

7 a. Contractual	\$1,420.00
8 b. Consumables	\$580.00
9 Total	\$2,000.00

10 Section 3. Allottee and Lapse Date. All funds appropriated by this act shall be allotted,
11 managed, administered and accounted for in accordance with applicable laws. The allottee of
12 the fund appropriated shall be the Governor of the State of Kosrae, who shall be responsible for
13 ensuring that these funds, or so much thereof as may be necessary, are used for the purpose for
14 which are appropriated and that no obligations are incurred in excess of the sum appropriated.


