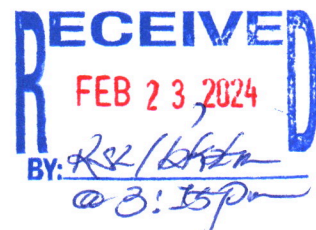



A BILL FOR AN ACT

To amend State Law No. 12-160, by amending Section 2, to extend lapse date of the grant to January 31, 2025; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this act is to amend Section 2 of State Law  
2 No. 12-160, to extend the lapse date of the grant.

3           Section 2. Amendment. State Law No. 12-160 is hereby amended to read as  
4 follows:

5           “Section 2. Allottee and Lapse Date. All funds appropriated by this act shall be  
6 allotted, managed, administered and accounted for in accordance with applicable laws.  
7 The allottee of the fund appropriated shall be the Governor of the State of Kosrae, who  
8 shall be responsible for ensuring that these funds, or so much thereof as may be necessary,  
9 are used for the purpose for which are appropriated and that no obligations are incurred in  
10 excess of the sum appropriated. The authority of the allottee to obligate the fund  
11 appropriated by this act shall be lapsed on January 31, 2025.

12           Section 3. Effective Date. This act takes effect upon the approval of the Governor  
13 or upon its becoming law without such approval.






