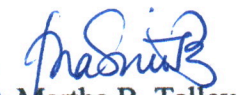

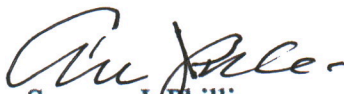

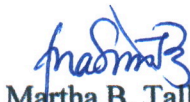

A BILL FOR AN ACT

To further amend State Law No. 13-98, as amended by State Law Nos. 13-103, 13-112, 13-119, and 13-120, by amending Section 10(2) at subsection (e) to modify the Kosrae Island Resource Management Authority's FY2025 approved budget for Fixed Assets; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1       Section 1. Purpose. The purpose of this Act is to further amend State Law No. 13-  
2   98, as amended by State Law Nos. 13-103, 13-112, 13-119, and 13-120, by amending  
3   Section 10(2) at subsection (e) to modify the Kosrae Island Resource Management  
4   Authority's FY2025 approved budget for Fixed Assets.

5       Section 2. Amendment. State Law No. 13-98, Section 10(2) is hereby amended to  
6   read as follows:

7               "Section 10. Apportionment. Operation of Certain Agencies. The sums  
8   apportioned by Section 9 of this Act are apportioned as follows:
