**A RESOLUTION**

Consenting and confirming the nomination of Mr. Hairom E. Livaie to serve as the Director for the Department of Transportation and Infrastructure.

1           **WHEREAS**, pursuant to Section 12 of Article V of the Kosrae State Constitution, each  
2 principal government department is under the supervision of the Governor and is headed by a  
3 director; and

4           **WHEREAS**, pursuant to Section 12 of Article V of the Kosrae State Constitution,  
5 directors are nominated and appointed by the Governor, with the advice and consent of the  
6 Legislature, to serve at the pleasure of the Governor during his term of office and until the  
7 appointment and qualification of their successors; and

8           **WHEREAS**, pursuant to Section 4.203(1) of Title 4 of the Kosrae State Code, the  
9 Governor nominates a person to the directorship of a department within sixty days of taking  
10 office following election; and

11           **WHEREAS**, pursuant to Section 4.203(2) of Title 4 of the Kosrae State Code, within  
12 sixty days of the Legislature's receipt of a nomination, the committee to which the Speaker  
13 assigns the nomination calls and concludes hearings on the nomination, unless the Legislature by  
14 resolution allows a further period; and

15           **WHEREAS**, through Governor's Message 12-03, transmitted and received on January  
16 24, 2019, Governor Sigrah has nominated Mr. Hairom E. Livaie to be the Director for the  
17 Department of Transportation and Infrastructure in the State; and

1           **WEREAS**, the Standing Committee on Environment, Transportation, Communication  
2 **and Infrastructure** has been assigned to work on the nomination and has concluded its work on  
3 the nomination of Mr. Hairom E. Livaie, to be the Director for Department of Transportation and  
4 Infrastructure in Kosrae State; and

5           **WHEREAS**, it is the finding of the Standing Committee on Environment,  
6 Transportation, Communication, and Infrastructure that the nominee, as exhibited by his resume,  
7 is qualified and able to carry out the duties and functions of the Director of Transportation and  
8 Infrastructure; **now and therefore**

9           **BE IT RESOLVED**, that this Twelfth Kosrae State Legislature, on its first Regular  
10 Session, February 2019, hereby consents and confirms the nomination of Mr. Hairom E. Livaie  
11 to serve as the Director for the Department of Transportation and Infrastructure; and

12           **BE IT FURTHER RESOLVED**, that certified copies of this resolution be transmitted to  
13 The Honorable Carson K. Sigrah, Governor of Kosrae State and to Mr. Hairom E. Livaie.
