A BILL FOR AN ACT


To amend the Kosrae State code by inserting a new subsection (4) under Section 7.1306 of the Kosrae State code to add extra powers and duties for the Housing & Rural Development Authority and to renumber duplicated numbering under 7.1306; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1	Section 1. Purpose. The purpose of this act is to amend the Kosrae State code by
2	inserting a new subsection (4) to Title 7, Section 7.1306 of the Kosrae State code to
3	include lending program to businesses to improve economic conditions and create jobs in
4	rural communities.
5	Section 2. Amendment. Title 7, Chapter 13, Section 7.1306 of the Kosrae State
6	Code is hereby amended to read as follows:
7	"Section 7.1306. To establish lending program to businesses to improve economic
8	condtioins and create jobs in rural communities.
9	(1) To manage, use, and invest the funds and other properties of the Kosrae
10	Home Improvement Program and other funds of the Kosrae Housing
11	and Rural Development Authority in accordance with acceptable
