A RESOLUTION

Consenting to and confirming the nomination of Mr. Smith T. Sigrah to serve as a member of the Kosrae Port Authority Board.

WHEREAS, pursuant to Section 12 of Article V of the Kosrae State Constitution, the Governor has the constitutional authority to appoint members comprising States Boards, Authority, Commissions or Agencies with the advice and consent of the Legislature; and 3 WHEREAS, Section 7.601 of the Kosrae State Code establishes the Kosrae State Port 4 5 Authority; and 6 WHEREAS, Section 7.606 of the Kosrae State Code further composes the Board of Directors with five voting members. Four Directors; one from each the four Municipalities, 7 appointed by the Governor with the advice and consent of the Legislature, and, ex-officio, the 8 9 Director of the Department of Transportation and Infrastructure. An appointed Director serves for a term of four years, subject to reappointment, and until his successor has been appointed and 10 qualifies. Initially, the Governor appoints two Directors to two-year terms and two Directors to 11 four-year term. A vacancy is filled for the remainder of the term for the vacated position; and 12 WHEREAS, by Governor's Message No. 13 - 141, Governor Tulensa W. Palik has 13 nominated Mr. Smith T. Sigrah to be a member of the Kosrae Port Authority; and 14 WHEREAS, the Speaker of the 13th Kosrae State Legislature has assigned Governor's 15 Message No. 13-103 to the Committee on Environment, Transportation, Communication, and 16
