**A RESOLUTION**

Consenting and confirming the nomination of Mr. Johnson A. Asher, Esq. to serve as the Attorney General for the State of Kosrae.

1           **WHEREAS**, pursuant to Section 12 of Article V of the Kosrae State Constitution  
2 each principal department is under the supervision of the Governor and is headed by a  
3 director. Directors are nominated and appointed by the Governor, with the advice and  
4 consent of the Legislature, to serve at the pleasure of the Governor during his term of  
5 office and until the appointment and qualification of their successors. Whenever a board,  
6 commission or other body is that head of a principal department or a regulatory or quasi-  
7 judicial agency, the members are nominated and appointed by the Governor with the  
8 advice and consent of the Legislature. The term of office and removal of members are  
9 prescribed by law; and

10           **WHEREAS**, pursuant to Section 4.203 of the Kosrae State Code, within sixty  
11 days of taking office following election the Governor nominates a person to the  
12 directorship of a department; and

13           **WHEREAS**, Section 5.201(6) of the Kosrae State Code establishes the Office of  
14 the Attorney General; and

15           **WHEREAS**, through Governor's Message 13-14, The Honorable Tulensa W.  
16 Palik, Governor of the State of Kosrae has nominated Mr. Johnson A. Asher, Esq. to  
17 serve as the Attorney General of the State of Kosrae; and

1           **WHEREAS**, the Standing Committee on Judiciary and Governmental Operations

10 A. Asher, Esq. to serve as the Attorney General for the State of Kosrae; and


11           **BE IT FURTHER RESOLVED**, that a certified copy of this resolution be
