

A BILL FOR AN ACT

To appropriate the sum of \$200,000 from the Revenue Fund of the Kosrae State Treasury to support the four municipalities in Kosrae; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$200,000.00 is from the Local Revenue
2 Fund of the Kosrae State Treasury to support the four municipalities in Kosrae. Usage of
3 fund shall be for municipal operations or activities and shall not be used to pay for legal
4 fees.

5 Section 2. Apportionment. The amount appropriated in Section 1 of this act is
6 apportioned as follows:

7	1. Tafunsak Municipal Government	\$50,000
8	2. Lelu Town Government	\$50,000
9	3. Malem Municipal Government	\$50,000
10	4. Utwe Municipal Government	\$50,000

11 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed,
12 administered, and accounted for in accordance with applicable laws. The allottee of the
13 funds appropriated shall be the Governor of the State of Kosrae, who shall be responsible
14 for ensuring that these funds, or so much thereof as may be necessary, are used for the

1 purpose for which are appropriated and that no obligations are incurred in excess of the
2 sum appropriated.

3 Section 4. Effective Date. This act takes effect upon the approval of the Governor
4 or upon its becoming law without such approval.
