A BILL FOR AN ACT

To amend the Kosrae State Code by amending Section 10.212 of Title 10, by adding a new subsection (3), to require re-appropriation by the Kosrae State Legislature for all audited unused money in the State General Fund at each fiscal year ending; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. <u>Purpose</u>. The purpose of this Act is to amend the Kosrae State Code by amending Section 10.212 of Title 10, by adding a new subsection (3), to require reappropriation of all audited unused money in the State General Fund at each fiscal year endings by the Kosrae State Legislature; and for other purposes.

Section 2. <u>Amendment</u>. Title 10, Section 10.212 of the Kosrae State Code is hereby amended to read as follows:

"Section 10.212. Unexpended funds.

- expenditure within a stated period becomes void to the extent that
 the appropriated sum is not obligated by the end of the period. A
 sum is available for expenditure for the purpose of the appropriation
 only if a valid obligation for payment of the sum occurs before the
 expiration of the period and the Director receives a copy of a valid
 document evidencing the obligation, certified by the allottee.
- (2) The Director may cancel an obligation not liquidated within one year following the date it became payable, as evidenced by a valid
