**A RESOLUTION**

Consenting to and confirming the re-nomination of Mr. Donald J. Mongkeya to serve as a member of the Kosrae Broadcast Board.

1           **WHEREAS**, pursuant to Section 12 of Article V of the Kosrae State Constitution,  
2 the Governor has the constitutional authority to appoint members comprising State  
3 Boards, Authority, Commissions or Agencies with the advice and consent of the  
4 Legislature; and

5           **WHEREAS**, Section 7.201 of Title 7 of the Kosrae State Code established the  
6 Kosrae Broadcast Authority; and

7           **WHEREAS**, Section 7.202 of Title 7 of the Kosrae State Code, the Authority is  
8 directed by a Board of five members who serve terms of two years. Until appointment of  
9 a majority of the board the Authority's affairs are managed by its highest-ranking staff  
10 person; and

11           **WHEREAS**, by Governor Message No. 13-108, the Honorable Tulensa W. Palik  
12 has re-nominated Mr. Donald J. Mongkeya to serve as a member of the Kosrae Broadcast  
13 Authority Board of Directors; and

14           **WHEREAS**, the standing committee on Environment, Transportation,  
15 Communications, and Infrastructure (ETC&I) has been assigned to work on the  
16 nomination and has concluded its work on the re-nomination of Mr. Donald J. Mongkeya  
17 to serve as a Board of Director for the Kosrae Broadcast Authority; and
