

A BILL FOR AN ACT

To amend State Law No. 12-190, at Section 2(10) to adjust the Special Education Program budget for fiscal year 2023; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this act is to adjust the Special Education Program
2 budget for fiscal year 2023 to reflect the actual U.S. Federal Program funding approved from the
3 FSM Special Education Program in the State of Kosrae.

4 Section 2. Amendment. State Law No. 12-190, Section 2(10) is hereby amended to read
5 as follows:
