A BILL FOR AN ACT

To amend the Kosrae State Code by amending Chapters 1 and 2 of Title 19, Section 19.315 under Chapter 3 of Title 19, Sections 19.812 and 19.816 under Chapter 8 of Title 19 of the Kosrae State Code, to enable the Governor to approve projects and developments during a State of Emergency; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Purpose. The purpose of this Act is to amend the Kosrae State Code by 2 amending Chapter 1 of Title 19 of the Kosrae State Code by inserting a new Section 3 19.104 there under to exempt any projects or developments undertaken by the State 4 Government on either private or public land given with the approval of the Governor 5 which are in response to a State of Emergency from any of the provisions contained in Section 19.102; and for other purposes. 6 Section 2. Amendment. Title 19, Chapter 1, of the Kosrae State Code is hereby 7 amended by adding new Section 19.104 thereunder to read as follows: 8 "Section 19.104 Exemption of projects and developments approved by the 9 Governor from the application and operation of the provisions contained in 10 Section 19.102: 11 (1) The Governor may may override and not be subject to any of the provisions 12 contained in Section 19.102 when subject to (2) below approving any State 13 Government project or development on either private or public land where any 14 such project or development is undertaken in response to a State of Emergency 15 and during a State of Emergency. 16

14	Any project of development approved by the Governor pursuant to Section 19.104

17	Section 5. <u>Purpose</u> . The purpose of this Act is to amend Section 19.315 under

Section 19.104 (1) or where such project or development has been extended by the 1 Legislature pursuant to Section 19.104(2). 2 Section 6. Amendment. Section 19.315 of Chapter 3 of Title 19 of the Kosrae State 3 4 Code is hereby amended to read as follows: 5 "Section 19.315. Compliance with Title. No person shall violate this Title, regulations adopted pursuant to this Title, written 6 7 fishing agreements, or any requirements or conditions of a permit issued issued pursuant to this Title except where such violation is excused in circumstances 8 9 where the Govenor has granted approval of a State Government project or development pursuant to Section 19.104 (1) or where approval of such project or 10 development has been extended by the Legislature pursuant to Section 19.104(2) 11 12 or where the Governor has given approval of a State Government project pursuant 13 to Section 19.812 (3) or where aproval of such project or development has been extended by the Legislature pursuant to Section 19.812 (4)." 14 Section 7. Purpose. The purpose of this Act is to amend the Kosrae State Code by 15 amending Section 19.812 under Chapter 8 of Title 19 of the Kosrae State Code to permit 16 any projects or developments to be undertaken by the State Government with the approval 17 18 of the Governor which are in response to a State of Emergency despite such project or development involving activities which are otherwise prohibited by Section 19.812; and 19 for other purposes. 20

Section 8. Amendment. Title 19, Chapter 8, Section 19.812 of the Kosrae State 1 Code is hereby amended by adding new subsections (3) and (4) thereunder to read as 2 follows: 3 "Section 19.812 Prohibited Activities Within the Kosrae State Protected Area 4 5 System. 6 7 (3) Despite the provisions contained in (1) and (2) above, The Governor may 8 subject to (4) below approve of any State Government project or development to 9 be undertaken within the boundaries of an area designated as part of the State 10 Protected Area System in circumstances where any such project or development is 11 undertaken in response to a State of Emergency and during a State of Emergency. 12 (4) The Legislature may by resolution passed by two thirds of its members revoke 13 or extend any approval of any project or development given by the Governor in the 14 15 provision contained in (3) above within thirty days after the Governor has given any such approval. 16 Section 9. Purpose. The purpose of this Act is to amend Section 19.816 so as to 17 make clear that the enforcement provisions contained therein do not apply to the approval 18 or extension of any project or develoment given pursuant to subsections (3) and (4) of 19 Section 19.812. 20
