

A BILL FOR AN ACT

To appropriate the sum of \$5,000.00 from the Revenue Fund of the Kosrae State Treasury to fund the 2024 International Women’s Day celebration by each community women association; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1 Section 1. Appropriation. The sum of \$5,000.00 is hereby appropriated from the
2 Revenue Fund of the Kosrae State Treasury to fund the 2024 International Women’s Day
3 celebration by each community women association.

4 Section 2. Apportionment. The sum appropriated shall be apportioned as follows:

5	1. Tafunsak Women Association	\$1,000.00
6	2. Lelu Women Association	\$1,000.00
7	3. Malem Women Association	\$1,000.00
8	4. Utwe Women Association	\$1,000.00
9	5. Kosrae Women Association	\$1,000.00

10 Section 3. Allottee. All funds appropriated by this act shall be allotted, managed, and
11 accounted for in accordance with applicable laws. The allottee of the funds appropriated by
12 this act shall be the Governor of the State of Kosrae, who shall be responsible for ensuring
13 that these funds, or so much thereof as may be necessary, are used as for the purpose of
14 funding the International Women’s Day and that no obligations are incurred in excess of the
15 sum appropriated.


16 Section 4. Effective Date: This act takes effect upon the approval of the Governor or
17 upon its becoming law without such approval.
