A BILL FOR AN ACT

To appropriate the sum of \$2,500 from the Revenue Fund of the Kosrae State Treasury for the Fiscal Year ending September 30, 2025, to defray all costs associated with the 2025 International Women's Day celebration by each community women association; and for other purposes.

BE IT ENACTED BY THE KOSRAE STAE LEGISLATURE

Section 1. Appropriation. The sum of \$2,500 is hereby appropriated from the

Revenue Fund of the Kosrae State Treasury for the Fiscal Year ending September 30, 2025, to defray all costs associated with the 2025 International Women's Day celebration by each community women association.

Section 2. <u>Apportionment</u>. The sum appropriated shall be apportioned as follows:

1. Tafunsak Women Association	\$500.00	
2. Lelu Women Association	\$500.00	
3. Malem Women Association	\$500.00	
4. Utwe Women Association	\$500.00	
5. Kosrae Women Association	\$500.00

Section 3. Reporting Requirement. After such fund is released from the State Treasury, each community women association is required to submit an expense report of all spending relative to the fund usage, two months after completion of activities. The report shall be submitted to Office of the Governor and the Kosrae State Legislature.

Section 4. Allottee. All funds appropriated by this act shall be allotted, managed, and

accounted for in accordance with applicable laws. The allottee of the funds appropriated by this act shall be the Governor of the State of Kosrae, who shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used as for the purpose of funding the International Women's Day and that no obligations are incurred in excess of the sum appropriated.

Section 5. Effective Date: This act takes effect upon the approval of the Governor or upon its becoming law without such approval.
