A BILL FOR AN ACT

To amend the Kosrae State Code at certain sections correcting typographic errors, spelling, and referenced sections as non-substantive amendments to the Kosrae State Code, as updated up to September 9, 2021; and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1       Section 1. Purpose. The purpose of this act is to provide non-substantive correction to  
2       the Kosrae State Code, as updated up to September 9, 2021. The non-substantive amendments  
3       include typographic, spelling, grammar, and formatting,

4       Section 2. Amendment. The Kosrae State Code is hereby amended as follows:
