A RESOLUTION

4 of Article V of the Constitution of the State of Kosrae considered the Declaration of State of  
5 Emergency ;; and

6           **WHEREAS**, members of the Twelfth Kosrae State Legislature after considering the  
7 Declaration of State of Emergency 'perceived that the Declaration of the State of Emergency  
8 requires to be amended so that monies currently held in the Department of Health's revolving  
9 fund can be better utilized by making such funds available in connection with the Governor's  
10 Declaration of State of Emergency as amended and consequently further perceived that existing  
11 section 9) made under the order under the Declaration of State of Emergency be substituted  
12 with a new section 9) and existing section 9) made under the order made under the Declaration  
13 of the State of Emergency be reinserted and renumbered as 10) ; NOW AND THEREFORE
