A BILL FOR AN ACT

To amend the Kosrae State Code by adding a new Chapter 4 and inserting there under Section 12.401 and Section 12. 402 of Part 1 of Title 12 Kosrae State Code. To further amend the Kosrae State Code by repealing the existing definition of sexual abuse in Section 13.312 of Chapter 3 of Title 13 of the Kosrae State Code and replacing it with a new definition of sexual abuse and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

Section 1. Purpose. The purpose of this Act is to amend the Kosrae State Code by 1 adding Chapter 4 Sex Abuse Education and Remedial Measures and inserting there under 2 Section 12.401 and Section 12.402 of Part 1 of Title 12 . 3 4 Section 2. Amendment. Title 12, Part 1 of the of the Kosrae State Code is hereby amended by adding there under Chapter 4 and there under inserting section 12.401 and 5 6 section 12.402 to read respectively as follows: "Chapter 4 Sex Abuse Education and Remedial Measures 7 Section 12.401 The Director of Education shall immediately study and as soon as 8 practicable develop and implement age and culturally appropriate child sexual abuse 9 identification and prevention curriculum for kindergarten through to fifth, eighth or twelth 10 grades to help children, teachers and parents to recognize child sexual abuse and further 11 provide for remedial measures such as some type of referral, counselling or safeway for 12 children to report incidences of child sexual abuse and require training for school 13 personnel. Upon written request of the pupil's parent or guardian, a pupil in kindergarten 14

or grades 1 to 12 inclusive, shall be excused from taking instruction in sexual abuse and

sexual assault awareness and prevention established pursuant to this section"

- Section 12.402 Immunity A person participating in the making of a report pursuant
 to this chapter is immune from civil and criminal liability arising from the making of the
 report and with respect to oral, written or other evidence he or she provides concerning the
 report in a judicial proceeding.
- Section 3. <u>Purpose</u>. The purpose of this Act is to further amend the Kosrae State

 Code by repealing the existing definition of sexual abuse in Section 13.312 and replacing

 it with a new definition:
 - Section 4 <u>Amendment</u>: Title 13, Chapter 3, Section 13.312 of the Kosrae State Code is hereby amended to read as follows:
- 12 "Section 13.312. Sexual Abuse. Sexual abuse is intentionally having sexual contact 13 with another person who is less than thirteen years old or causing the person to have sexual contact with the offender. Sexual contact means any touching of the sexual or other 14 intimate parts of another done with the intent of gratifying the sexual desire of either party. 15 Sexual abuse of a person who is less than 18 years of age or who is incapacitated (as 16 defined in Section 6.3702 (3) of the Kosrae State Code) includes any act which exposes 17 the person to or involves the person in sexual processes beyond the person's 18 understanding or contrary to accepted community standards." 19
