



A BILL FOR AN ACT

To further amend State Law No. 13-98, as amended by State Law Nos. 13-103 and 13-112, by amending Section 10 at subsection (1)(c) to modify the Broadcast Authority's FY2025 approved budget for Contractual (office building renovation); and for other purposes.

BE IT ENACTED BY THE KOSRAE STATE LEGISLATURE

1           Section 1. Purpose. The purpose of this Act is to further amend State Law No. 13-

2           98, as amended by State Law Nos. 13-103 and 13-112 by amending Section 10 at

3           subsection (1)(c) to modify the Broadcast Authority's FY2025 approved budget for

4           Contractual (office building renovation).

5           Section 2. Amendment. State Law No. 13-98, Section 10 is hereby amended to




