A RESOLUTION

Consenting to and confirming the nomination of Mr. Rolinson B. Neth to serve as the Director for the Department of Health Services.

1           **WHEREAS**, pursuant to Section 12 of Article V of the Kosrae State Constitution, each  
2 principal government department is under the supervision of the Governor and is headed by a  
3 Director; and

4           **WHEREAS**, pursuant to Section 12 of Article V of the Kosrae State Constitution,  
5 Directors are nominated and appointed by the Governor, with the advice and consent of the  
6 Legislature, to serve at the pleasure of the Governor during his term of office and until the  
7 appointment and qualification of their successors; and

8           **WHEREAS**, pursuant to Section 4.203(2) of Title 4 of the Kosrae State Code, within  
9 sixty days of the Legislature's receipt of a nomination, the committee to which the Speaker  
10 assigns the nomination calls and concludes hearings on the nomination, unless the Legislature by  
11 resolution allows for a further period; and

12           **WHEREAS**, through Governor's Message No. 12-343, received on November 2<sup>nd</sup>, 2021,  
13 Governor Sigrah has nominated Mr. Rolinson B. Neth to serve as the Director for the  
14 Department of Health Services for the State of Kosrae; and

15           **WHEREAS**, the Standing Committee on Health and Social Affairs has been assigned to  
16 work on the nomination and has concluded its work on the nomination of Mr. Rolinson B. Neth  
17 to be the Director for the Department of Health Services in the State of Kosrae; and

8 The Honorable Carson K. Sigrah, Governor of the State of Kosrae; and to Mr. Rolinson B. Neth.


